A Resolution by the Pinal County Board of Supervisors requiring
Financial Disclosure by Public Officials

WHEREAS, A.R.S. § 38-545 requires every incorporated city or town or county to adopt standards of financial disclosure for local public officers consistent with the provisions of A.R.S. Title 38; and

WHEREAS, Public Officer means a person holding a county elective office of Pinal County, except for Judges of the Superior Court; and

WHEREAS, Every public officer shall file with the Clerk of the Board of Supervisors a sworn Financial Disclosure Statement, covering the pervious calendar year, on or before January 31 of each year;

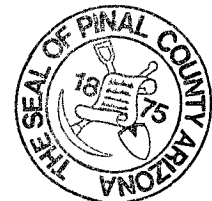
WHEREAS, The sworn Financial Disclosure Statement shall contain all information required by A.R.S. § 38-541 through A.R.S. § 38-545 and shall be filed on a form provided by the Clerk of the Board, which is the same form as required by the Secretary of State.

NOW, THEREFORE, BE IT RESOLVED, that Pinal County hereby adopts all of the standards and provisions of A.R.S. §§ 38-541-545 as the standards of financial disclosure to be applied to all local public officers within Pinal County.

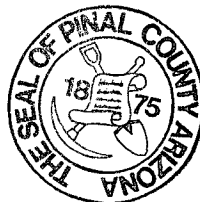
